- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

### **Scope of this Privacy Policy**

- 3. This Privacy Policy applies only to the actions of Centre Tap Electronics Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Centre Tap Electronics Ltd is the "data controller". This means that Centre Tap Electronics Ltd determines the purposes for which, and the manner in which, your Data is processed.

#### **Data Collected**

- 5. We may collect the following Data, which includes personal Data, from you:
  - a. name;
  - b. date of birth;

  - f. IP address (automatically collected);

#### How We Collect Data

- 6. We collect Data in the following ways:
  - a. data is given to us by you; and
  - b. data is collected automatically.

## Data That is Given to Us by You

- 7. Centre Tap Electronics Ltd will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you register with us and set up an account to receive our products/services;
  - c. when you make payments to us, through this Website or otherwise;
  - d. when you use our services;

in each case, in accordance with this Privacy Policy.

### **Data That is Collected Automatically**

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

#### Our Use of Data

  - in each case, in accordance with this Privacy Policy.

- 11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

- 12. We will use technical and organisational measures to safeguard your Data, for example:

  - b. we store your Data on secure servers.
  - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

## **Your Rights**

  - e. Right to data portability the right to request that we move, copy or transfer your Data.
  - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
